#### A Great Win for Pro-Lifers at Last!

In February 2017, the Queensland Parliament was asked to vote and pass 2 proposed abortion laws in order to reform past laws which made abortion illegal.

Independent member for Cairns Mr Rob Pyne who introduced to private members Bills and called on his colleagues MPs to "embrace this historic opportunity" and pass the bill which would see abortion legal to full term of gestation and decriminalise abortion.

However, thanks to the work of pro Life groups and massive prayers and other spiritual acts these proposed Bill were by Mr Pyne himself, moved a motion to withdraw the Bills from the Notice Paper and withdraw them from further Parliament debate because they were defeated. Over! Done!

At least for now, though I'm sure at some time in the future some other attempts will be made.

These two Bills which were heavily canvassed and promoted by Mr Pyne and pro-abortion/pro-choice groups were not going to be passed once it was understood that parties like LNP (Coalition) Katter Party, One Nation MP Steve Dickson and several Labor members would not support the Bills. These members are to be thanked and congratulated for standing tall and saying NO. The LNP maintained its promised not to touch or be in favour of the changing of the current abortion laws.

This outcome reminded me of some words Mr Turnbull (now our Prime Minister) said many years ago when he was a Liberal MP, and these words have stayed with me. Indeed he was, at the time, one of the voices raising alarm in Federal Parliament. At the time he warned that falling fertility rates would be, what he called, "a looming catastrophe" These words stuck, and he continued saying that such decline in fertility, posed one of the greatest threats to Western society. Listen to this

he continued with "far worse than global warming and terrorism!" Then he went on to say that he believes "we have failed women, you are free to be in the workforce, and you have equal rights as men, but this with a silent proviso: so long as you are not a mother." Dear friends I remember these words because I have a notepad in which I keep quotes which are of importance to me.

Many factors contribute to women not wanting children but have instead a strong desire to be out in the workforce. Contraception (which said no to children, I can control my fertility) abortion on demand, education of women which then of course would lead to a desire to do the work which they studied so hard for. Six years of university then of course a desire and demand the right to use the knowledge, and the slow change of what it means to be married and form family.

Of course it has also been said that workplace rules demand that having children and their care is difficult and unviable. And so childcare facilities thrive with government/taxpayer subsidising. This, together with contraception (no to children) and abortion (no to children) another separation between mother and child. Post contraception, post abortion, there is also childcare available so that women can return to work as soon as possible.

How I wish that women would understand that the early formative years are so important to children. The years where their voice of authority (Mum/dad), security, stability, right and wrong, is learned and remains as guidance for all lifetime.

Great as childcare facilities are and of course there are times when a woman has to work to help maintain children, the reality is that even in the choice to work is their "choice" for self-fulfilment above that of the child and child's formation.

Motherhood today is not honoured. Woman is not considered honoured and "with child" but woman is encouraged to enter the workforce and be productive there.

Motherhood is not so attractive especially if thought that childcare is available and subsidised. No help available for mothers if they wish to remain at home during their child's formative years so that their own voice becomes the child's voice of authority and not the many transient workers at day-care centres.

As I said and stress, I understand that there are times where the ideal is not possible, but surely we can find ways and funds to assist women to stay with their babies and little ones while their early formation is accomplished.

The human heart has a longing to belong to a human family to have communion with others who are of their own "kind." We as a society must fight the urge to separate and divide the family and recapture the real divine truth of what it means "family." It requires strength, direction, and leadership and love.

Protection from both mother and father in their unique role creation, and guidance and education of their children for this life and then for heaven.

Woman's most important role is to love. Woman is to be the love of God "visible" man is to be strength, protection and love of God "visible." He is to be the labourer in the garden whilst she is to love and nurturer the fruit which he tends to in the garden. Then perhaps we might have less violence in our world.

...so just for a few minutes lets celebrate that win...

we can do it.

The voices of 55,000 people signing petitions to reject these Bills were heard. The thousands who marched against these new Bills/Laws means that their voices were heard. The nearly 3,000 (in fact 2,800) submissions to the Parliamentary inquiry into this legislation, of these 80% were found to be against changes. Again their voices were heard. Indeed our members of parliament are elected by us and at times they listen. The changes sought for open slather death of pre born babies in Queensland, a beautiful state in Australia, were found to be unacceptable to Queenslanders.

Sadly but not unexpectedly, now there is a move to refer the bills to the Law Reform Commission (which is what happened here in Victoria) and I can foresee that the LRC of Queensland will probably go the way of the

> Victorian LRC which eventually passed the worst abortion laws known. Abortion to full term without discussion or interference which led to eventually the bubble zones around abortion facilities (150 metres).

However just for now we have seen that it is possible for good to win. And perhaps for Queensland pro-lifers time to prepare for the outcome of the Qld LRC.

There seems to be an all-out attack on innocence. An all-out "desperate need" to allow women and men to kill babies without any

fallout or consequences. There is an all-out need, for some reason, to change the culture and nature of the human person where only the human person has a right, a need, a want to intentionally kill their own child.

Its lunacy, this society that we have created. And then we wonder why other issues all demand their so called rights. (I have recently read that paedophiles also demand their rights!) We have set the groundwork for all the moral changes we are seeing now because of rejection by woman of her child. If the value of life is nil and up for disposal then of course other values become disposable too. Other definites become malleable and changeable.

But for this time, dear friends, we had a great win so just for a few minutes let's celebrate that win and I wish to say thank you to all who fought this battle.

And now we have to all work to rewind the Victorian Fiasco.

#### Sorry I digressed a bit!

If the second Qld abortion bill - Health (Abortion Law Reform) Amendment Bill 2016 - had been successful then guidelines, such as the establishment of 50 metres "safe zones" and gestational limits would have been ensured. No different than we have in Victoria.

The Queensland Premier, Ms Anastacia Palaszczuk said she believed abortion should not be in the Criminal Code. "It is an incredibly complex issue and I think there would be a very strong view that it should not be a crime." "However, I do have some concerns about the second bill so I will have a look at that." (safe zones and gestational age) which she said are "personal issues too, between a woman, her family and her doctor. "Very sensitive, very emotional, very complex."

Perhaps what we can learn from this experience is that if enough people get behind saving in utero babies then

#### **Abortion Laws Northern Territory** 2017

Under the new legislation (passed March 2017) women in the Northern Territory (for my overseas readers another state in Australia) will now also have access to legal abortion and have available the abortion pill RU486.

"We believe all Territory women are entitled to control over their lives and access to high quality services," Said Health Minister Natasha Fyles.

The laws which existed before in the Northern Territory permitted abortions after a woman was assessed by two medical doctors and carried out in hospitals in either Darwin or Alice Springs. Chief Minister Michael Gunner, who was a strong supporter of the bill, said the change of laws now provides Territory women the same choices afforded to others around the country. "It's my belief that existing Territory legislation unintentionally discriminates against Territory women," he said.

What terrifies me is the idea that the early abortion pill RU486 is available to women and especially those in outback areas. We know that there have been deaths both in Australia and overseas by women taking this pill yet the NT health minister and NT Chief Minister applaud the new laws and the availability of RU486.

I'm wondering will the media report any deaths that occur outback if and when a woman takes RU486 past the 50 day so called safe mark? (7 weeks gestation formed and with a heartbeat.)

What about someone who is 65 days (9 weeks) and takes the so called safe "abortion Pill" begins to bleed to death. Will Ms Fyles or Mr Gunner take responsibility for these deaths? Are Northern Territory women so disposable that their health is jeopardised so much?

It is said that abortion, both chemical and surgical, is the safest of medical procedures but what about those who have died as a result of the chemical or surgical abortions. A procedure which was sold to them as quick, safe and oft performed. Perhaps the families who have suffered the loss of their loved one should be asked if it was quick and easy or has it meant for them huge loss and not easy at all and for them no matter how often it is performed their loved one died. I personally am so concerned with the ease of availability of RU486 to Territorian women, some who are distant from medical facilities and hospitals and may suffer sepsis which is blood poisoning. Or when the chemicals released

by the immune system to fight an infection cause inflammation of the whole body and can be very fatal.

has had for the aborting woman and how this one procedure has been the catalyst for life changes.





HIDDEN PAIN is written about memories which are hidden and cannot be spoken out loud. It is a book about shame, pain, sorrow and lives which have gone wrong both for victims, families, and perpetrators. Sexual abuse of children is common in all communities, in all societies, and yet it's still one of the last remaining taboos. It is something which cannot be spoken about because it's so awful, so inappropriate that it cannot be discussed. Yet discussed it must be, because the children are crying and pleading to be helped.

This is not a step by step guide to dealing with abuse. It is the result of my engagement with those who have come to me originally for post abortion counselling and on further investigation it was found that abuse (especially in cases of multiple abortions) existed in their history. It is my hope that *HIDDEN PAIN* can be of help to those who read it and more so be vigilant and not to turn away when a child is suffering.
