# Our Children living in the Lord.

Joshua 22:26-28

Therefore, we said, 'Let us now build an altar, not for burnt offering, nor for sacrifice, but to be a witness between us and you, and between the generations after us, that we do perform the service of the Lord in his presence with our burnt offerings and sacrifices and offerings of well-being; so that your children may never say to our children in time to come, "You have no portion in the Lord."

This is one of the Old Testament quotes which I love and which I believe fits beautifully with pro life charism.

I have over the years encountered many well-meaning good Catholic/Christian individuals who like and support me and the work that I do. However, what they do object to is my belief that aborted, miscarried, stillborn children are "Living in the Lord" (St John Paul II E.V99) and following this belief I help the hurting parent/s believe that one day they will meet their baby face to face.

The difficulty they have (especially Catholics) is that word "Limbo" and all who die (including aborted, miscarried and infant deaths and deaths of righteous ones) without baptism will go to a -place of peace and beauty but never to enjoy the vision and company of the Lord.

With this belief it makes it very hard to convince a hurting mother that God has forgiven her and one day she will meet her child.

An oft cited response to "Limbo" is "if my baby can't ever see God. I don't want to either because I'm the guilty one. Not my baby" And before I get a mountain of letters correcting me, please don't. I do know that it

was a theory proposed by St Augustine but today we understand that we entrust our infants into the care and Mercy of God who does not want anyone to be lost. I have another theory which I am working on but not ready yet. It is such a beautiful theory but I need to do more research so I will leave it at that. To come.

The verse from Joshua spoke to me so clearly. It's almost like it was written for our time and this particular sin (abortion). A sin so huge that it leads to some saying "your children have no portion in the Lord" (aborted children/miscarried/unbaptised children) because of the manner of their dying. These children, our children, 50,000,000 children per year may be placed near the Lord "but they have no portion in the Lord" And yet we have a recent Pope who has now been declared saint (St John Paull II) who has spoken as "Peter" saying "your children are living in the Lord" (EV 99) Using almost the same words living "in the Lord" and Joshua "no portion in the Lord."

I take great pleasure and joy in being able to help abortive mothers maintain continuing bonds with their aborted baby/ies because of the hope that one day they will be able to meet and mother the baby which they sent back unmet.

"so that your children may never say to our children in time to come (our day) you have no portion in the Lord"

After many moments and hours of sharing, listening, weeping, laughing. After many months of regretful memories and record keeping and making mental searches, after many months of self-deep looking, deeper and deeper to see who this person is the moment came when I whispered --- "I can see me. I can see how good I have been created, loved, nurtured by God my Father. I have a father who loves me (not like this earth one) without conditions and without ever leaving me and without impositions. I have a Father I can trust. I have a Father I can feel, hear, know him. I am His child."

(Words from Tash (not her real name) who felt really forgiven and understood why she is forgiven because she is His daughter and is loved)

It had been a difficult road with Tash who didn't want forgiveness for her abortion. She wanted to stop feeling so sad and in pain over her decision but she didn't deserve to be forgiven. also, because she believed that legal abortions are good for women so that "women no longer die in lanes from botched abortions" Much clarification from me regarding this was needed

Throughout our many earlier sessions there was a tug of war going on within her. A side of her which was "really sad" over the death of hers and so many babies but another side of her believed strongly that women should be able to have abortion facilities available so that "backyarders" don't do the "procedure" I believe it was this incongruence which caused the dissonance within her.

Her original session with me ("I'm only coming once because I promised my mum I would come") turned into many on again off again first in Melbourne and since followed here in Perth, via zoom, but when she came, she was hesitant but always left more peaceful. With this person I left her appointments to be made when she thought she could cope with another session.

As time and sessions passed, I helped her find the reason within her for her inconsistency in belief and emotions and as she slowly came to look at episodes in her own life and those who were part of those episodes, she came to see things in her ideas slowly change.

In due course even her early life religious beliefs and family beliefs surfaced (Christian) and we were able to talk about these and relate the beliefs with "life" and God and her journey away from her family and beliefs. Over the several years of sessions we covered much and it was a great joy for me to see her understand herself and where the difficulties were and her response to the difficulties and the not so good decisions she made because of the difficulties.

Our sessions, when I moved to Perth, stopped for a time until she came to a day where she needed to talk to someone and we reconnected. Since then, as in the past sessions only when needed. However, I did experience a moment of happiness when she made the comment "I can see me. I can see how good I have been created, loved, nurtured by God my father. I have a father who loves me etc" (see beginning of this piece.)

Our sessions now have taken a really new and completely different but happy turn. And personally, I don't believe she needs to be with me anymore but I will leave this to her. As I do with all my past clients the door remains open just in case there is a need to

talk. And ves, she does believe that she is loved and forgiven both by her baby and God and is at peace with both.

And this is the beautiful outcome I hope for when a new client begins with me.

# The year that's been.

Dear friends, as I come to the end of this last newsletter for 2021, a year unlike any other we have known in our lifetime. I would like to say that I have achieved much but the reality is that like all of us I

> have not done the things I would have liked to have done as in past years.

> Looking through my diary I had given three talks to two different groups, on abortion grief and one on the similarities and differences between abortion grief and sexual abuse grief. I have been back to Melbourne once (early in year) and given each of my clients two sessions each in the week I was there and then had to hurry back before borders closed.

...I'm glad they brought the child to birth...

> Since that time, I have given two further talks on abortion grief and one of these talks was to professional people.

I have continued to counsel my Melbourne clients (weekly) either by phone and zoom and whilst it has not been the same as per "normal" it has been acceptable.

I continue with zoom with four clients now and I enjoy a little because we are able to see each other but I also enjoy speaking by mobile (3) with those without zoom.

During this time, I have written the usual number of newsletters per year (6 issues) and have written quite a few articles for publishing both in Australia and overseas.

.I haven't been able to establish referrals from pregnancy helps but I am meeting Life people here though have had referrals from Melbourne people and places I know and who know the work that I do.

I had hoped to have done something very special for babies here but I haven't been able to bring this about yet but I haven't given up on that project. I hope as things ease more can be done. I have joined several pro-life/family groups which helps me be connected with other like-minded people.

I am now in my office (here) 3 ½ days per week and other work, especially writing I do from home office because all my resources are there. The writing is very very important because its part of what I set out to do 25 years ago, that is public education about the damage/harm which abortion does to baby, woman, man, family, society.

I have been unable to order the other plague for two babies (Melbourne client) for the South Melbourne Children's memorial wall (they should've been installed but border and lockdown difficulties), hopefully will go to Melbourne as soon as I can then we will discuss and go see other plaques so that my girl will not have to experience seeing plaques by herself. This is important.

Sadly, this now seems impossible as our illustrious leader has decreed WA border won't open till end January/Feb). However, it seems borders are moveable for sporting functions.

I also hope to have another two+1 plaques available to place on the memorial wall sometime in the new year but again its difficult to make plans for now, and perhaps when I go to Melbourne beginning of year will speak with my clients about a saying goodbye ceremony we might do whilst I am there.

Normally I would attend 2-3 overseas conferences per year and several in Australia, where I would deliver a paper on either of my two topics but this year as you can imagine all cancelled because our international and national borders closed

Even attending to ongoing professional development seminars have been difficult as I don't like doing webinars. I like the interaction with others and sharing of information.

All in all, I have done as much as it was possible to do with the limited possibilities. I am hoping to close office by third week in December and reopen end of January but as always available in emergencies.

I sincerely hope that by time of return to work some kind of "normal" will have been restored and we can look back at these past many months as a time when we were all tried and tested and hope we have passed the tests posed before us.

### Interesting experience.

A new client came to see me, (I'll call her Jenny, not her real name) a youngish lady who supposedly came to see me re her recent abortion and the after effect of her sadness and sorrow and tears and sleepless nights and anger. All the usual effects after abortion. But somehow beginning from the call to make the appointment to her arriving and completing necessary consent forms and my making a cup of tea for me and water for her, I felt niggling sensation. A feeling that something was not right.

Yes, she did complete the necessary forms, yes, she was pleasant but sad looking. Very smartly dressed. Everything which should have made me feel OK. But still the nagging feeling continued.

After pleasantries and some information about her life and boyfriend, and family and work we got down to the issue of her abortion 8 weeks earlier when she was 11 weeks pregnant. The sad look continued and even what appeared forced tears. But as usual I continued finding out more about her relationship (he'd gone by now) her work (she couldn't take time off) and the need for the abortion.

As I said, everything should have been as past cases and story about her life and ultimate decision but that nagging feeling continued.

At some point in the session, she started to tell me that she felt sad that she had to do this abortion but she didn't really want the "foetus"? or to be pregnant (my radar started transmitting). She thought that maybe she wanted the "foetus"? but really, she had too much to do before having a baby. In fact, she simply didn't want to be pregnant at this stage of her life. "I'm too voung."

As I sat there listening and by now on alert for something which didn't sound right, she continued by telling me that after the abortion she started experiencing symptoms of "post abortion syndrome" Now my radar went into overdrive because no one uses "post abortion syndrome" when they are genuinely hurting. They don't use "foetus" or even "post abortion grief" and using the word "ambivalence" is a dead give-away.

However, I continued to sit there, listening and occasionally nodding and letting her do all the talking. Indeed, I was told about her feeling "ambivalent"? before the abortion. She felt like getting "drunk" was "depressed" had "sleepless nights" "dreaming about

her "baby" (now baby) She Missed her "baby" she wanted to "cut myself" and she was afraid that God wouldn't forgive her.

Her next question was "Anne do you help with religious and talk about God and the baby being with God?" Again in 25 years of this work no one has come out and asked do I speak about God to someone whose had an abortion. At least not until I have discerned that she has some sort of faith/religion background or she speaks about it herself and invites dialogue. The reason for this being that the "client" can complain to my peak body and say that I "forced" my religion on him/her.

So, faith, belief, God, heaven even plaque for baby comes after many sessions and usually if it's appropriate.

As we continued our session, I was further alerted to something not quite right because she made the comment "I know that I've had an abortion and am upset but I believe that abortion is a woman's right. It's her body and she shouldn't have to carry a pregnancy unless she wants to.

Keeping my Italian temper firmly in check I smiled politely and said "but Jenny why are you here with me if you think abortion is OK and a woman's right especially as you now know that there is a pain in the heart after the abortion even if it wasn't there before the abortion.

"Not until its born and the woman wants it. While it's in her body it's like a parasite it lives off her so she can get rid of "It" if she wants to" (parasite? "it")

Well, I still continued being a "nice counsellor" and asked if I could go make another tea for me and cold drink for her. She agreed. This gave me time to compose myself and still smile politely sitting at the desk.

We continued with inanities for a while and then she introduced her belief that both abortion and euthanasia are important because the planet is over populated so the numbers have to be reduced. By abortion and "older sick people"

I suppose I would have been forgiven if I "lost it" but I didn't I simply asked her "so I suppose its Ok that your baby is now gone?" No response.

"Jenny, tell me why are you here with me if you have such beliefs?" Silence for about a minute. Then "Anne I'm sorry but I wanted to know if you could help me" "I can help you but with what? How?" Would you like to talk about your abortion, your boyfriend, the

reasons for the decision to abort, how you felt before the abortion and what about now?"

Suddenly "Jenny" put her glass down stood up and said "Anne can I please think about this and maybe come back in a week or two?" "Of course, you can when you are ready.' And she bolted out of the door.

It's my suspicion that this was a pro-abortion individual from some abortion facility or connected with some anti-life organisation, with google learned behaviour and symptoms. Over 25 years I have experienced about half a dozen such episodes and this dishonesty upsets me but it shouldn't be surprising. Today I am alert to the language used and withdraw when I encounter such behaviour. A report to my peak body, an investigation especially if it says I have "pushed" my religion on her (I don't) could see me deregistered and I then can help no one. So, I am now careful.

No, she hasn't called back and has not come back and her mobile number was false. Didn't bother with rest of information as that too would be false. Though I have kept it.

I personally am glad she chose to go as I don't like to tell someone I don't want to see them. This way it's better.

Personally, I suspect that she has had an abortion or more by the coldness with which she spoke about a woman's right to have abortion. Parasite. Foetus. Euthanasia "because there are too many people on the planet" and other words says to me that she has for some reason accommodated her actions (abortion) and joined others who have done the same.

I have thought about her and thousands of others like her and wonder where has the feminine gone? We can see the feminist but where has the feminine gone.?

Being now more aware, I do wish she would come back for more iced water for her and tea for me and maybe a long chat. It would be so good. But I won't hold my breath.
